

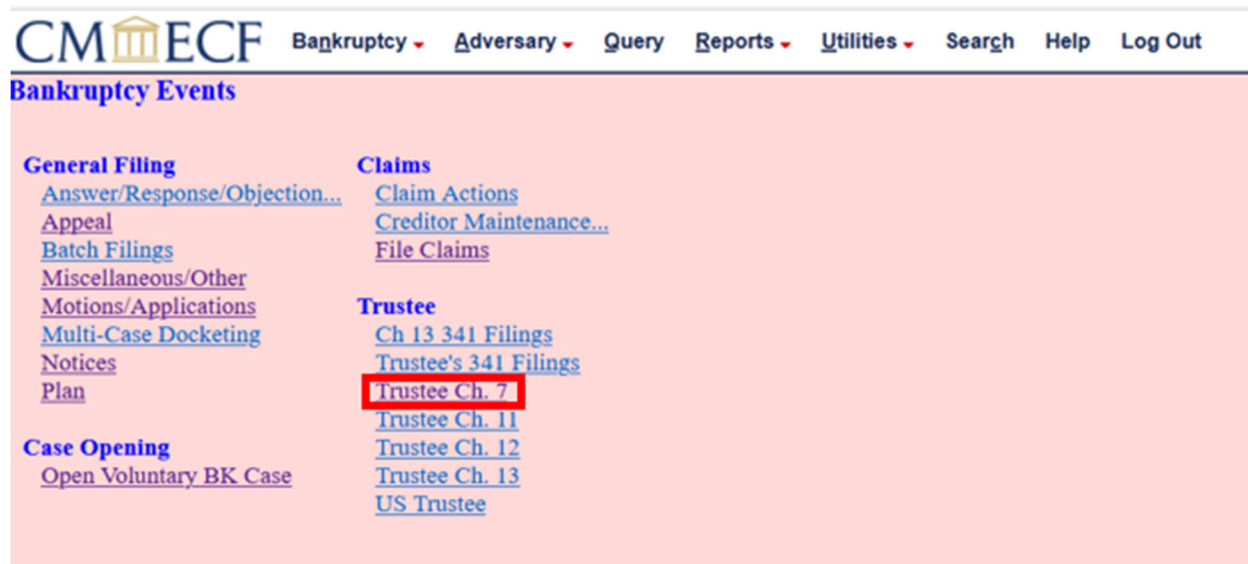
## Objection to Claim

This will go over the screens of how to file an Objection to Claim. Prior to starting the action, you will need to verify any information that needs to be redacted is redacted in your word document of the Objection to Claim. Then please print your Objection to Claim document into PDF format (which flattens the document). NOTE: Do not just save the word document as a PDF because that does not flatten the document and may allow for editing to occur.

Click on Bankruptcy on the CM/ECF Main Menu Bar.



Click on **Trustee Ch. 7**.



Enter the **Case Number** and click **Next**.
